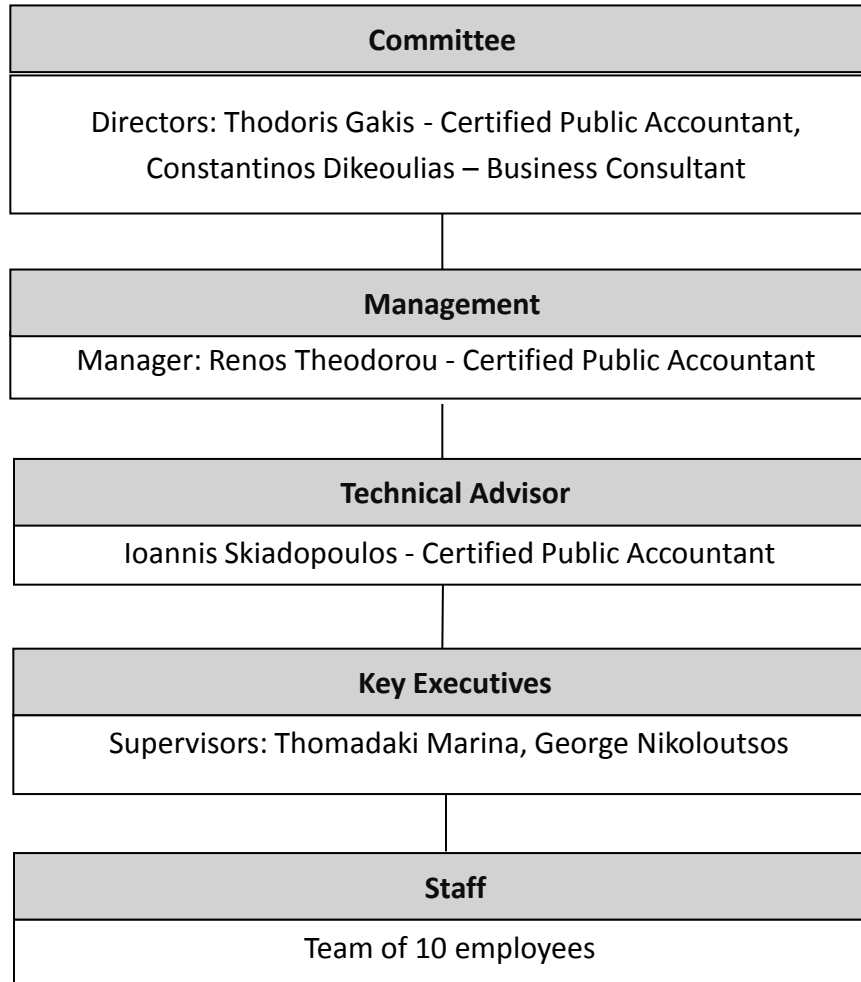
Giannis Skiadopoulos – Technical Advisor
